Re: Ratings of IndoStar Capital Finance Limited (IndoStar)

India Ratings (see definition below) assigns the following ratings of IndoStar:-

- INR3.50bn Non-Convertible Debenture (NCD): 'IND AA-'; Outlook Stable

The above rated NCD's are yet to be issued.

India Ratings (see definition below) affirms the following ratings of IndoStar:-

- INR3.0bn (decreased from INR4.85bn) Non-Convertible Debenture (NCD): 'IND AA-'; Outlook Stable

- INR1.34bn (decreased from INR3.75bn) Bank loans (details in Annexure 1): 'IND AA-'; Outlook Stable

Of the above IndoStar has already issued INR3.0bn of the rated NCD.
